



#### 1.Prayer

Doug (Chair) called the meeting to order; Ken opened in prayer.

#### 2.Welcome & Introductions

Doug welcomed all present and invited each person to introduce themselves and their connection to OIM.

#### 3.Approval of Agenda

Doug outlined the purpose of holding an Annual General Meeting:

- o Review 2019 financials
- o Review 2020 budget
- o Appoint Auditors
- o Ratify new members of the Board
- o Doug asked if anyone had any questions
- o Doug asked for a motion to accept the agenda.

\* Motion accepted; seconded; carried

#### 4. Approval of the previous AGM Minutes

Doug invited everyone to review last year's minutes and opened the floor for questions.

\*Motion made to approve last year's AGM Minutes; seconded; carried.

Ken informed all present who has voting rights: Board, Staff, as well as anyone who has donated \$500 and above (in the previous year) or anyone attending on behalf of an organization (e.g., church) that has donated \$500 and above (in the previous year) must be identified as a voting member. Everyone else is welcomed to partake as observers to the meeting, in accordance with the Governing Constitution.





#### 5.Board Chair's Report

Doug submitted his report and then addressed the group:

- Doug noted that OIM will be ratifying 2 Board members
- Doug thanked Ken and staff for the excellent job in not only excelling but leading among the agencies during these difficult times of COVID-19.
- Doug thanked the volunteers who wanted to do outreach and reach out to the clients, even to the point of risking their own health.
- Doug thanked the Board Members who went above and beyond in these trying times of difficulty.

Doug indicated this will be his last year as Chair of the Board. Next year at the AGM, a new Chair will be named while he will step away on a one year minimum sabbatical in accordance with the Governing Constitution.

#### 6.Executive Director's Report

Ken presented his 2019 report and addressed the group:

- Ken expressed his gratitude to the staff and volunteers for their support and continued performance of excellence.
- Ken indicated that OIM is now performing door ministry on Tuesday and Thursday and we are looking forward to expanding services in June to those on the streets.

#### 7.Review of 2019 Financials (Audit & AGM Statistics)

Bethany reviewed the 2019 audit & 2019 AGM Report, noting the following:

- The number of volunteer hours has increased from last year.
- The amount spend on salaries has increased from last year because of new positions added.





Question: It mentions Starbucks, do they donate? Answer: Yes they provide pastries for the drop-in and our office programs.

#### 8. Approval of the 2020 Budget

Bethany noted that there were no amendments/modifications to the Budget due to COVID at this time. If this does extend into the fall, we will have to reassess at that time.

At the moment, we are planning on going ahead with the non-event event and hope to increase income. There will still be a cost incurred to events that may not happen.

Recommendation made by Warren to show the budget and actual for 2020 as well as the 2021 budget so it is easier to see how we stayed within budget.

#### 9. Appointment of the Auditor for 2020

\*Motion made to keep the same auditors (dependent upon the second motion). Seconded; carried

Ken noted that with Bethany doing the taxes for OIM, our auditor fees should have decreased from last year however that wasn't the case. Ken and Bethany will be discussing the fees with the auditors and permission was requested that should they not be decreased, that the Board will look for another auditor.

#### 10.Ratification of New Board of Director(s)

Doug called for a motion to ratify Dr. Robert Yelle and Taffy Nahas to the Board.





Ken: Dr. Yelle is a previous Board Member and Chair to the Board so has extensive background with OIM. Taffy Nahas is presently a volunteer with OIM and will be a welcomed asset to the Board.

Doug indicated that it was great having so many in attendance today.Based on the attendance, the Board may look at more online Annual General Meetings.

Taffy thanked Ken and the staff for the outstanding work performed during these difficult days.
